

Terms and Conditions for Use of LINAK® OneConnect™ App:

Welcome to LINAK® OneConnect™ App

These Terms and Conditions shall apply to your use of the LINAK OneConnect Portal:

Your installation and use of the LINAK® OneConnect™ App ("App") is conditioned on your acceptance and compliance with these terms. Once you have downloaded the App, these terms will automatically apply to you and other users of the App. Therefore, you should make sure that you read them carefully before using the App. If you do not wish to be bound by these terms, then stop using the App.

These terms apply to all visitors, users, and others who access or use the App. All references to "you" in these terms also refer to other users of the app installed on your device.

Intended use: With the App you can read data from the LINAK hardware in your nearby surroundings. The App allows for display of data from LINAK hardware mounted in medical device through Bluetooth® advertisements from the LINAK products.

How does the App work: The LINAK One Connect App displays various data from LINAK products built into the medical device. You will also be able find additional product information about the medical device in the App, which is provided for your information by each of the manufacturers of the medical device.

It is a precondition for communication between the LINAK hardware and the App that you have following mechanisms are in place:

- the LINAK hardware is powered
- the LINAK product software supports system status
- the LINAK product has built-in Bluetooth®
- your mobile device has enabled Bluetooth and for Android also location sharing; and
- that you are within Bluetooth range of the LINAK hardware.

If you wish to see the list of LINAK products that are compatible with the App, please contact your local LINAK entity.

Data Collection: The App does not store any data about you. You are not asked to create any profile to access the App. Nor does the App collect and store any data that has been displayed from the LINAK products. Should you wish to keep this data you will have to do that in other media i.e., by making screen dumps to your mobile device.

None of the LINAK products, mounted to the medical devices, do record that the Bluetooth advertisement has been read by your mobile device. Hence, LINAK nor the manufacturer of the devices can track afterwards that you have been accessing data.

Intellectual Property Rights: You are not allowed to copy or modify the App, any part hereof, or LINAK trademarks in any way. You are not allowed to extract or attempt to extract the source code or make derivative versions. The App itself, and all the trademarks, copyright, database rights and other intellectual property rights related to it, belong to LINAK.

The Product information and Product pictures stored in the App belongs to each of the medical device manufacturers. These medical device manufacturers are fully responsible for the content they have uploaded to the App and further you respect their Intellectual Property Rights.

Limitation of Liability: LINAK shall not incur any liability if an attempt to transmit data to the App is not successful. This could be due to that one of the preconditions in section "USE"

above are not complied with or due to other devices' interference with the signal from the LINAK devices and thereby weakening the reception of LINAK signal in the App.

LINAK does not warrant the functionality of the App, the service or any information provided through the App. LINAK cannot be held liable for any reduced functionality or performance of the smart device on which the App is installed.

To the maximum extent permitted by the applicable law, LINAK accepts no liability for any loss, direct or indirect, you experience because of relying on this functionality of the App.

Changes, Expiry and Termination: At some point we may wish to update the App as we know that an app in general is not error-free or without defects. LINAK does not promise that we will update the App. However, you promise to always accept updates to the App when offered to you.

We may also wish to stop providing the App and may terminate use of it at any time without giving prior notice of termination to you. Unless we tell you otherwise, upon any termination, (a) the rights granted to you in these terms will end, (b) you must stop using the App, and (if needed), delete it from your device.
