Misc. on the TWINDRIVE® system

This system is a TWINDRIVE system developed for leisure beds and for indoor use in private homes.

Warranty

This HOMELINE product is subject to warranty pursuant to the terms of LINAK HOMELINE Warranty Paper, available on the LINAK website www.linak.com/warranty.

Maintenance

Clean dust and dirt on the outside of the system at appropriate intervals and inspect them for damage and breaks. Inspect the connections, cables and plugs and check for correct functioning as well as fixing points.



The cleaners and disinfectants must not be highly alkaline or acidic (pH value must be 6-8).



It is not allowed to use solvents for cleaning up.



Max. load running back and leg end motors at the same time in upward direction is 5500 N on back motor, and 5500 N on leg end motor.



For customers in the US/Canada:

The mains cable for this product has a polarised plug (one blade is wider than the other). It will only fit in a polarised outlet one way. If it does not fit fully in the outlet, reverse the plug. If it still does not fit, contact a qualified electrician to install a proper outlet. Do not change the plug in any way.

Description of the TWINDRIVE® system

Each TWINDRIVE® unit consists of 2 internal motors and a built-in control box, which makes it a very compact unit. The mains cable is exchangeable. Only the handset must be paired.

Application of the TWINDRIVE system:

Irrespective of the load the Duty cycle: 10 % ~ max. 1 minute at continuous use followed by 9 minutes pause. Do not turn on the system if it is not mounted in a bed.

The TWINDRIVE is a Bluetooth®-based system, which means you can use hand controls based on Bluetooth. LINAK® offers a range of compatible hand controls. Alternatively, the Bed Control App can be downloaded to use a smartphone as handset.

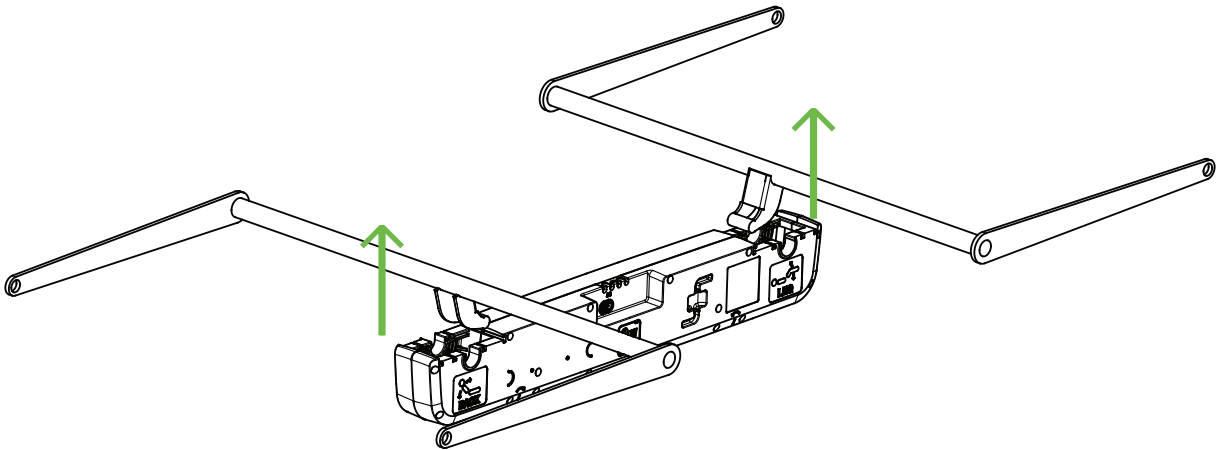
You can pair eight hand controls to one TWINDRIVE. You can also pair both hand controls and app controls to the same TWINDRIVE, but only eight controls in total. If you pair more hand controls than the TWINDRIVE can manage, the first paired hand control will be deleted.

This user manual gives you a detailed description on how to pair your hand controls with your TWINDRIVE.

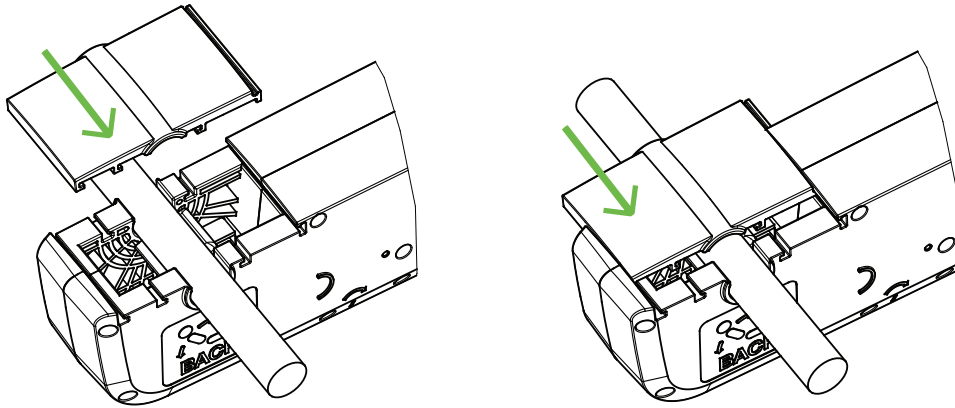
Installation

Mounting the TWINDRIVE

1. Push the TWINDRIVE unit into bed bracket.

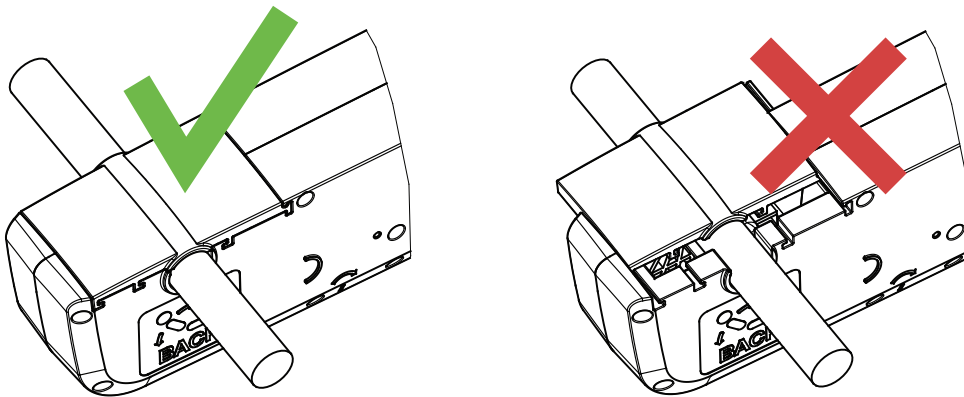


2. Slide each closing device on and press it into correct position.



IMPORTANT:

Ensure that the closing devices are in place before using the TWINDRIVE.



Do not drive the TWINDRIVE system without the closing devices mounted.

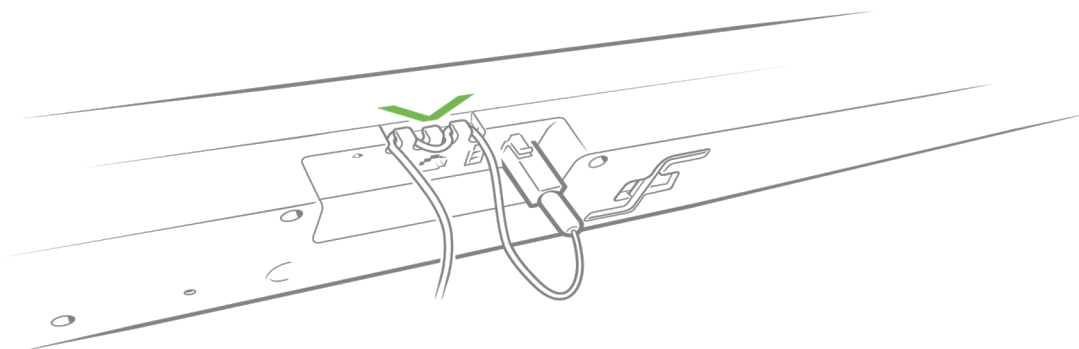


The bed brackets must have a smooth surface without burs and welding blobs in the area where the TWINDRIVE is mounted.

Cable strain relief



Use the cable strain relief on the TWINDRIVE Advanced. By using the relief, you prevent the mains cable plug from being pulled out of the TWINDRIVE resulting in a malfunction. Depending on the thickness of the cable, you can choose to lead the cable through all three reliefs or just around the middle relief.

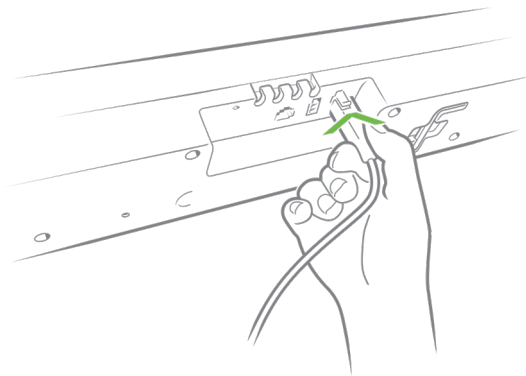

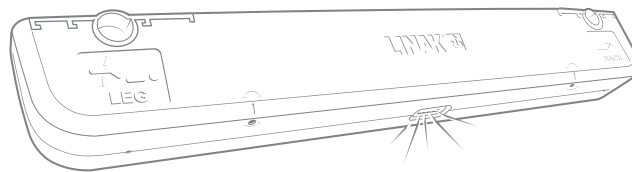
Ensure that only the TWINDRIVE you want to pair with is in pairing mode.

Pairing your control

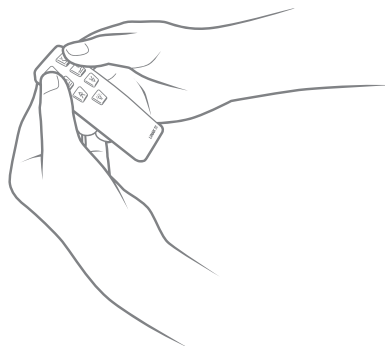
1. Connect the TWINDRIVE Advanced to mains via the mains cable.



2. The TWINDRIVE is in pairing mode for 3 minutes and the Under Bed Light flashes to indicate this.



3. Press the two top buttons on the LINAK hand control at the same time.



The Under Bed Light gives one long flash to indicate that the hand control and the TWINDRIVE are paired up. The TWINDRIVE stays in pairing mode and it is possible to connect more controls using the same procedure.



Wait 5 seconds after pairing control 1 before you can pair control 2.

To get the system out of pairing mode, simply press any button on an already paired control.

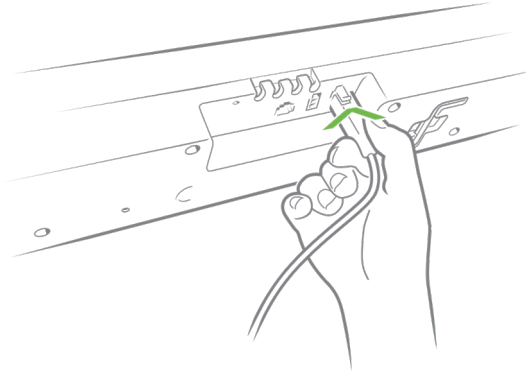


Allow for the hand control to go to power-saving mode (backlight turns off) before disconnecting the actuator system from the mains supply.

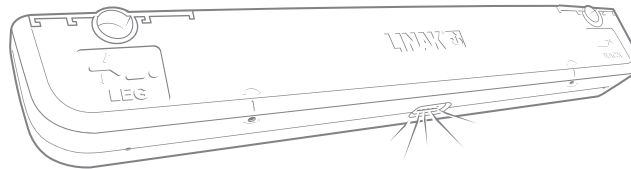
Otherwise the pairing will not be saved in the hand control.

Pairing your smartphone or tablet

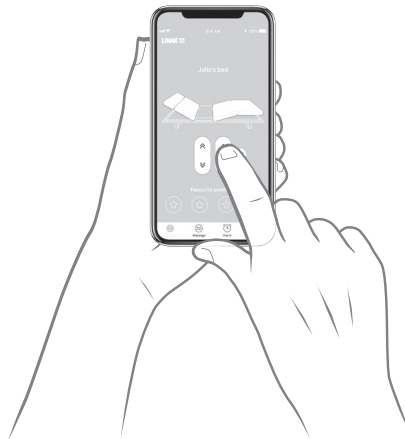
1. Enable Bluetooth® on your smartphone/tablet.
2. Open the Bed Control App.
3. Connect the TWINDRIVE Advanced to mains via the mains cable.



4. The TWINDRIVE is in pairing mode for three minutes and the Under Bed Light flashes to indicate this.



5. The Bed Control App will automatically pair to the closest TWINDRIVE in pairing mode. Wait a few seconds to see the app confirm completed pairing.
6. Your smartphone/tablet and the TWINDRIVE are now paired up. The app will display the operation page and the bed can now be adjusted via the app.

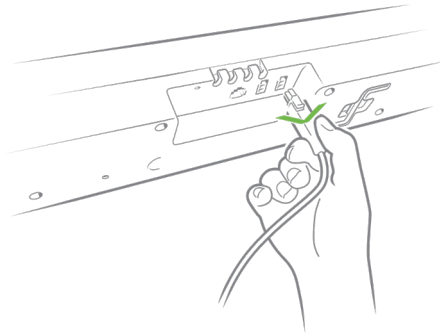


The Bluetooth® pairing mode will stop as soon as the phone is connected. Thus, we recommend to start pairing the hand control and thereafter the phone to avoid having to disconnect the power.

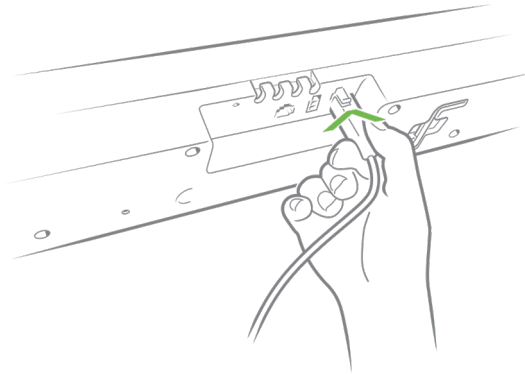
Pairing another device later

It is possible to connect another control or another smartphone/tablet to the TWINDRIVE later.

1. Disconnect the TWINDRIVE Advanced from mains.



2. Wait 2 minutes.
3. Reconnect the TWINDRIVE to mains to get it in pairing mode again.



4. Follow the instructions above to pair other devices.

Previously paired devices will not be deleted until a maximum of 8 devices are paired. Pairing a ninth device will delete the first device paired.



The TWINDRIVE will be in pairing mode every time the system has been out of power and connects again. To get the system out of pairing mode – simply press any button on an already paired device.

Quick pairing mode

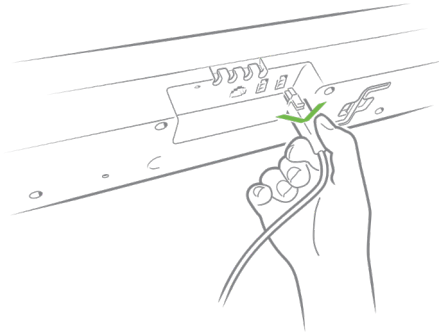
You can also pair a new device by using the quick pairing mode.

1. Turn on the Under Bed Light.
2. Disconnect from mains.
3. Wait until the Under Bed Light turns off.
4. Reconnect the TWINDRIVE to mains to get it in pairing mode again.
5. Press the two top buttons on your hand control at the same time.
6. The Under Bed Light gives a long flash to indicate that control and TWINDRIVE are paired up.

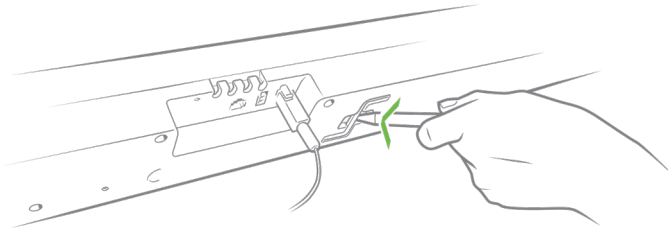
Mechanical emergency lowering

Emergency lowering is meant for lowering the bed if a power failure occurs and the bed needs to be driven down into horizontal position.

1. Disconnect the TWINDRIVE Advanced from mains.

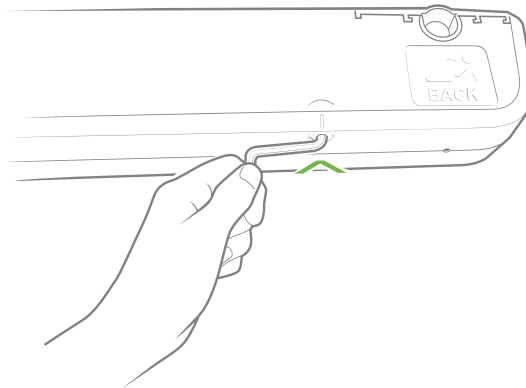


2. Take the hex key from the side of TWINDRIVE.



Underneath the TWINDRIVE are two gaps for mechanical lowering.

3. Place the hex key in the gap, one end at a time, and turn the hex key in the direction indicated by the arrow right above the gap.



It is important to turn the key in the direction indicated on the housing. Turning the key in the wrong direction can wreck the inner hex and make mechanical emergency lowering impossible.

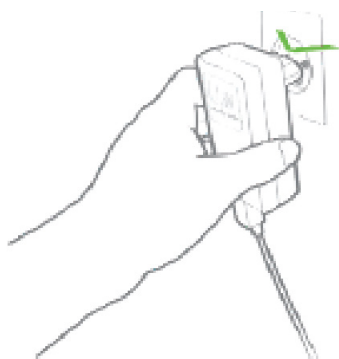


Do **not** use an electric screwdriver for lowering, use the hex key enclosed on the TWINDRIVE.

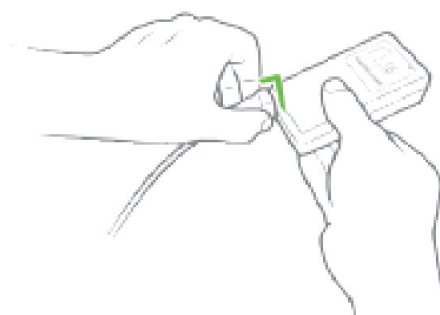
Electrical emergency lowering

Connection of emergency lowering:

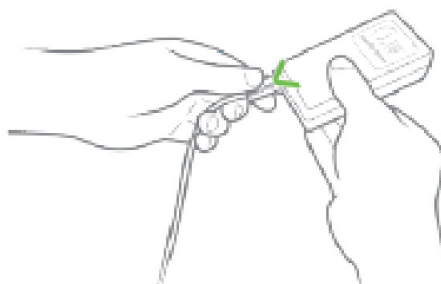
1. Disconnect the SMPS from the mains.



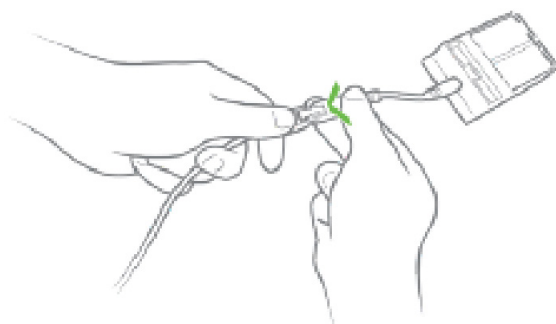
2. Notice! If a locking device is mounted on the SMPS remove it now.



3. Unplug the connection cable from the SMPS



4. Connect the connection cable to the battery box for emergency lowering.



Parallel drive

Parallel drive is supported by the following hand controls:

- HC20
- HC40 FRAME Advanced
- HC40 TWIST Advanced

It is possible to run parallel drive on two TWINDRIVE Advanced connected. Parallel drive means two beds running in parallel with use of only one hand control. Connect the two TWINDRIVE Advanced with a serial cable using the RJ45 ports. Use an already paired hand control or pair a hand control to the TWINDRIVE Advanced and control the two TWINDRIVE Advanced using only one hand control. It is possible to pair multiple hand controls to the system.



Wait for 5 seconds before switching hand control.

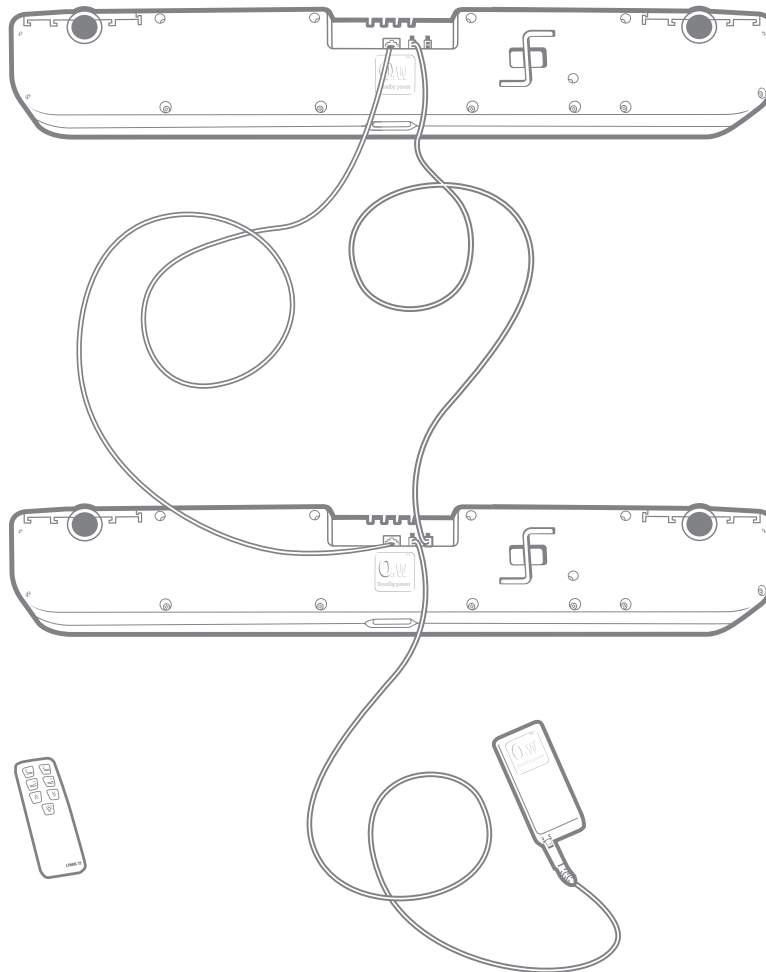


Figure 1 Connection overview for parallel drive on two TWINDRIVE Advanced

Combining the TWINDRIVE Advanced and the CBD6DC HOMELINE

Combining the TWINDRIVE Advanced with the Control Box CBD6DC HOMELINE makes it possible to create a bed design with up to 5 motor in the system. The CBD6DC HOMELINE is connected to the TWINDRIVE Advanced with a serial cable and a 2-poled DC cable for communication and power supply in between the products. For CBD6DC HOMELINE connection descriptions.



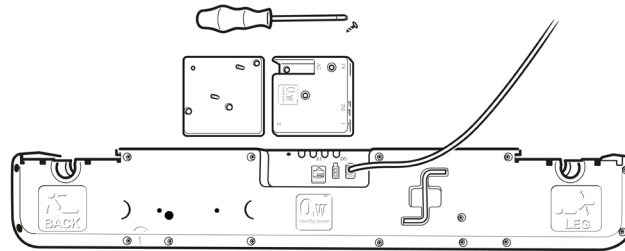
Do not pack the CBD6DC in heat insulating material.
Place the CBD6DC so it can emit heat through its surface to the surroundings.

Mounting the CBD6DC on the TWINDRIVE Advanced

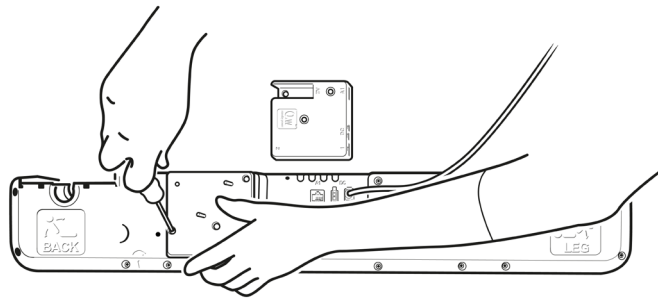
1. The CBD6DC can be mounted directly on a TWINDRIVE by means of the bracket and one screw.



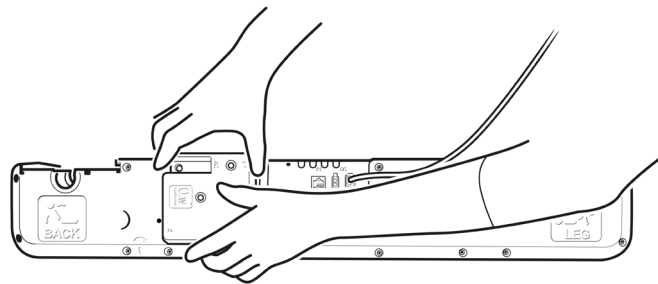
The bracket and the screw must be ordered separately..



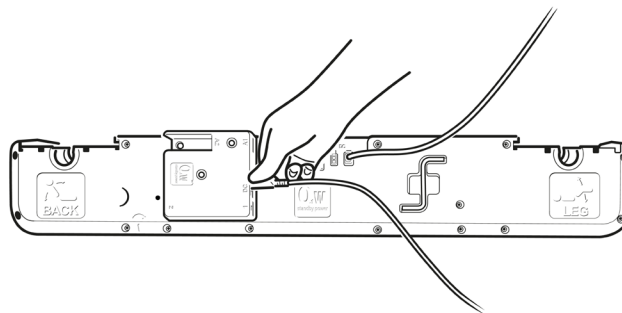
2. The bracket fits into the existing screw holes in the TWINDRIVE. Place the bracket on the TWINDRIVE and fasten the screw.



3. Place the CBD6DC on the bracket. Push down until it is clicked onto the bracket.



4. Plug the cables into the CBD6DC and the TWINDRIVE.

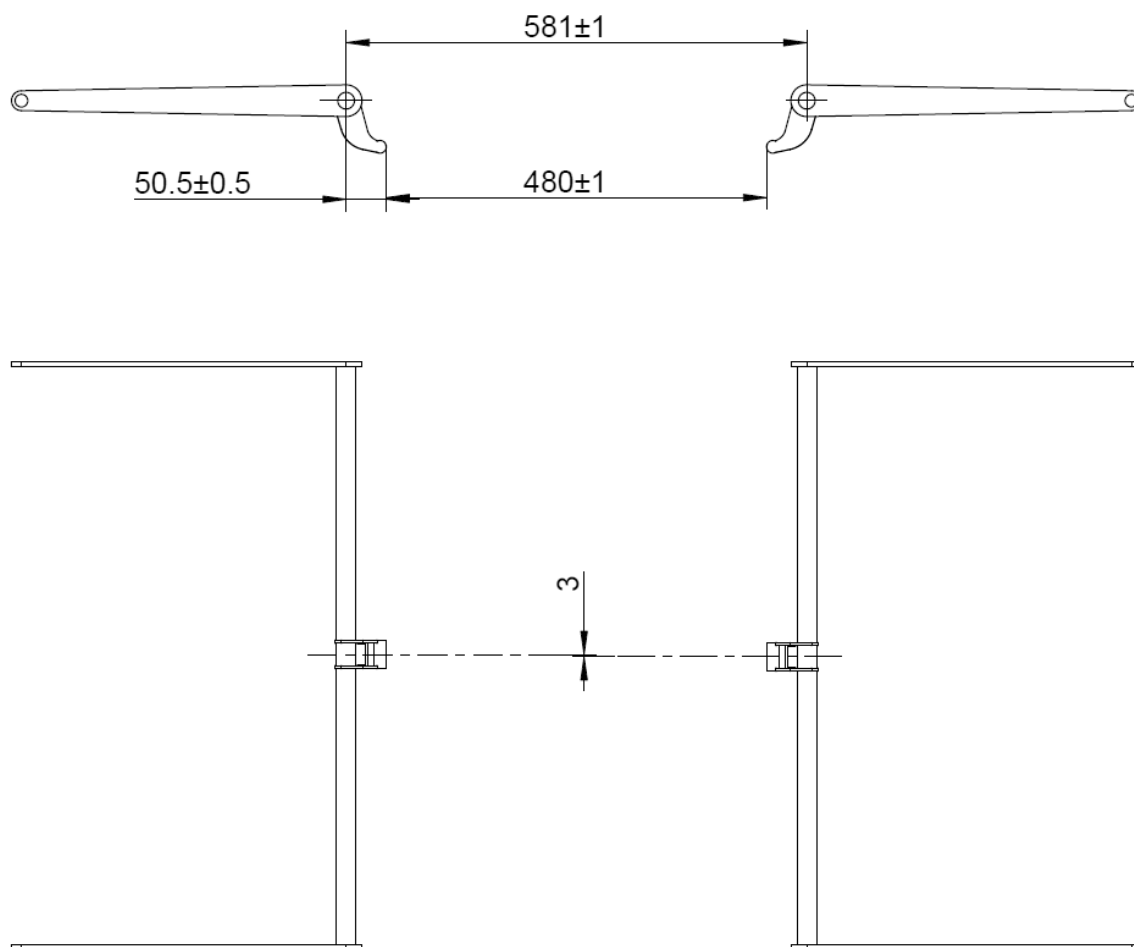


It is important to fix the cables to the bed frame to ensure that the cables are not stressed when the bed is adjusted.

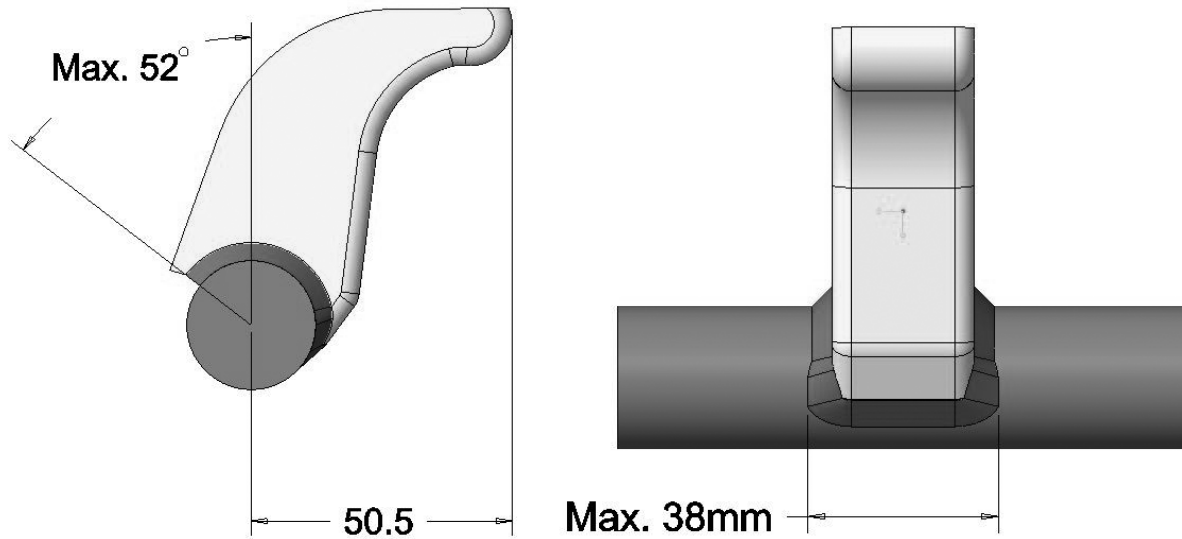
Mounting instructions and parallel tolerance

When bed is horizontal (starting position):

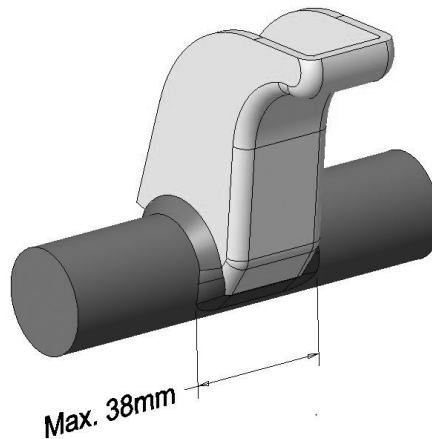


The shaft diameter must be $\varnothing 25.2 \text{ mm} +0.3 \text{ mm}/-0.2 \text{ mm}$

Welding instructions



No bracket or welding outside this area 52° from vertical axis



The dimension of the twist bracket including welding may not exceed 38 mm.

To maintain the correct rotation angle of the head-rest and the foot-rest it is important that the Twist bracket is mounted and welded according to the above instructions. Non-compliance with the instructions could lead to a smaller angle of rotation or, in worst case, damage the TWINDRIVE.



It is important that the bracket specification is met to keep the specified lifetime of the TWINDRIVE.

If the twist brackets are mounted correctly, 1-2 seconds after activating a hand control the bed should be adjusted. It gives the optimized mounting of the TWINDRIVE during mounting and the correct angle of the bed.

Repairs

Only an authorised LINAK® service centre should repair the LINAK actuator systems. Systems to be repaired under warranty must be sent to an authorised LINAK service centre.

In order to avoid the risk of malfunction, all actuator repairs must only be carried out by an authorised LINAK Service shop or repairers, as special tools and parts must be used.

If a system is opened by unauthorised personnel there is a risk that it may malfunction at a later date.

LINAK systems or components may be disposed of, possibly by dividing them into different waste groups for recycling or combustion.

We recommend that our product is disassembled as much as possible at the disposal and that you try to recycle it. LINAK systems or components should be disposed of in accordance with the environmental regulations applicable in the respective country.

Disposal of LINAK products

As LINAK customers often ask us how our products can be disposed or scrapped we have prepared this guide that enables a classification to different waste fractions for recycling or combustion.

Guide

We recommend our products to be disassembled as much as possible and divided into different waste groups for recycling or combustion.

For example, waste can be sorted into metals, plastics, cable scrap, combustible material, and recoverable resources.

Some of these main groups can be further divided into subgroups; e.g. metal can be divided into steel/aluminium/copper and plastic can be divided into ABS/PA/PE/PP.

As an example, the table below breaks down the different components in LINAK products to various recycling groups:

Disposal of batteries
